

Insights & Answers

A catastrophic event requires a well-managed and well-informed decision-making process to ensure business continuity and damage minimization. A fast, accurate, and complete understanding of contractual options and obligations is an essential requirement for the decision-making process before, during, and after a crisis.



The accelerator provides insight into the contracts which allow for quick action. Which contracts contain language explicitly calling out the event as a force majeure event, but require notice? Which contracts do not include the catastrophic event (fire, pandemic) as an expressly stated force majeure event, but the force majeure clause does cover government-imposed lockdowns? What are the potential consequences of a breach/default if a contract does not include a force majeure provision? Under which law is the contract governed, as different legal jurisdictions may treat a force majeure clause differently. The accelerator lets you easily bucket your contracts into risk categories and measures required, allowing companies to take action proactively, rather than later defending inaction.

Components
